LvlUpGames L.L.C. Privacy Policy

At LvlUpGames L.L.C., we prioritize the protection of your data and are dedicated to safeguarding it. This Privacy Policy elucidates the information we collect about you, the reasons behind it, how we utilize that information, and our approach to handling such data. 1. INFORMATION WE COLLECT

When you engage with our Services, we collect the following types of information.

ACCOUNT INFORMATION

Certain information is necessary to establish an account on our Services, including your name, email, password, and in-game name (e.g., summoner name, battle.net id, etc). If you choose to log into LvlUpGames with a social networking credential, such as your Facebook, Google+, Twitch, or Steam account, we will seek permission to access basic information from that account, such as your name and email address. You have the option to cease sharing that information with us at any time by revoking LvlUpGames' access to that account.

ADDITIONAL INFORMATION

To enhance your experience or enable specific features of the Services, you may opt to provide us with supplementary information, such as your product and game preferences to personalize your account. You may also connect with friends on the Services or invite friends who have not yet joined by providing their email addresses, accessing social networking accounts, or using the contact list on your mobile device. We do not store your contact list and erase it after utilizing it for adding contacts as friends. If you contact us or partake in a survey, contest, or promotion, we collect the information you submit, such as your name, contact information, and message.

2. INFORMATION FROM THIRD-PARTY SERVICES

When utilizing our Services, we require data about your game performance, such as the latest match details, season stats, etc., obtained from the game publishers' APIs. To facilitate this, we utilize the in-game name you provided during the registration process. If you opt to link your account on our Services to your account on another service, we may receive information from the other service about you, including details you've made available via your privacy settings. For instance, connecting to Facebook, Google, Twitch, Steam, and/or Discord may provide information like your name, profile picture, age range,

language, email address, and friends list. You can choose to grant us access to your gameplay, exercise, or activity data from another service, and you have the option to stop sharing this information by revoking our access to that other service.

3. INFORMATION WE RECEIVE FROM YOUR USE OF OUR SERVICES

A. LOCATION INFORMATION

Upon creating an account with us, we receive signals about your current location from information such as your IP address or device settings. This is essential to securely and reliably set up and maintain your account and provide our services to you.

B. USAGE INFORMATION

When you access or use our Services, we gather specific usage data. This includes details about your interactions with the Services, such as viewing or searching specific player performance, creating or logging into your account, or engaging with a particular Service feature. We also collect data about the devices and computers you use to access the Services, including IP addresses, browser type, language, operating system, the referring web page, pages visited, location, and cookie information.

4. HOW WE USE INFORMATION

We utilize the information we collect for the following purposes:

A. PROVIDE AND MAINTAIN THE SERVICES

This involves utilizing your information to calculate your performance, provide your Gamer Performance Index (GPI), deliver personalized advice, showcase your recent activity and other trends, enable community features, and offer customer support. For community features, we may use your information to help you connect with other users and vice versa. For instance, your account contact information allows users to add you as a friend. If another user has your email in their contact list or in their friend network on a connected service, we display that you are a user of the Services.

B. IMPROVE, PERSONALIZE, AND DEVELOP THE SERVICES

The collected information is employed to enhance and personalize the Services and to develop new features. This includes troubleshooting and error protection, conducting data analysis and testing, performing research and surveys, and creating new features and Services. We also use your information to make inferences and display more relevant content, such as personalizing advice based on your in-game performance and tailoring

quests, challenges, and goals based on your historical performance data and previously set or achieved goals.

C. COMMUNICATE WITH YOU

We use your information to send Service notifications and respond to your inquiries. Additionally, we may use your information to promote new features or products we believe would interest you. You have control over marketing communications and most Service notifications through your notification preferences in account settings or via the "Unsubscribe" link in an email.

D. PROMOTE SAFETY AND SECURITY

The information collected is employed to enhance the safety and security of the Services, users, and other parties. This includes user authentication, secure payments, protection against fraud and abuse, response to legal requests or claims, audits, and enforcement of our terms and policies. We utilize cookies and similar technologies for the described purposes. For more details, please refer to our Cookie Privacy Policy. Other information, such as your performance data obtained from game publishers' APIs or calculated with our algorithms, is retained as long as required for our legitimate business interests. We also maintain information about you and your use of the Services for the duration necessary for our legitimate business interests, legal compliance, and to prevent harm, as outlined in the "How We Use Information" and "How Information Is Shared" sections.
